## Bill Will Provide Property Tax Relief to Seniors

For years, we have heard talk about the need to provide property tax relief. Despite all the talk, Pennsylvanians are still waiting for that relief.

I believe our goal should be the reduction and eventual elimination of property taxes for every Pennsylvanian. But while we work toward that goal, something must be done to provide immediate relief to the Pennsylvanians who need it most: our senior citizens.

That is why I will be introducing legislation that will provide unprecedented property tax relief to some 600,000 Pennsylvania seniors by eliminating school property taxes for those seniors who make less than \$40,000 a year.

Pennsylvania's senior citizens have worked all of their lives to achieve the American dream of owning their own home. For many of them, rising property tax bills are turning that dream into a nightmare. My legislation will give them the relief they so desperately need.

## Bill Will Help in the Recruitment and Retention of Volunteer Emergency Personnel

Volunteers are the backbone of Pennsylvania's emergency services corps. The volunteer firefighters and emergency service personnel who protect our communities are our neighbors and our co-workers. They volunteer their time out of a sense of duty to the community and they deserve our thanks.

Unfortunately, our volunteer fire and EMS services have experienced a recent decline in the recruitment and retention of volunteers. I will be introducing legislation to help deal with that problem and make it easier for our volunteers to participate in necessary and timely training.

My legislation will:

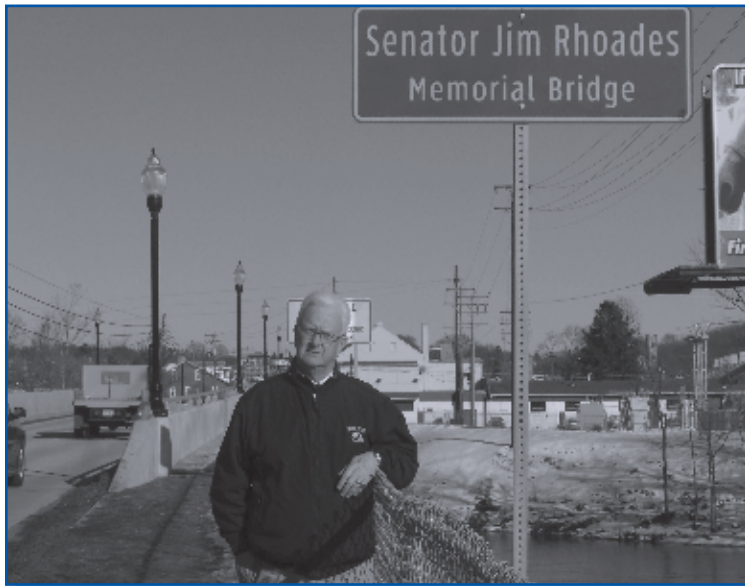
- Encourage private employers to permit an employee who is an active volunteer to leave work in response to an emergency call.
- Encourage private employers to permit an employee who is an active volunteer to take a paid leave of absence at the request of a fire chief to participate in bona fide training.
- Require the Commonwealth and its political subdivisions to permit employees who are active volunteers to respond to an emergency call prior to or during work hours, with or without pay, and without loss of time or efficiency rating.
- Prohibit all employers from discriminating against, refusing to hire or employ any individual due to their being a member of a volunteer emergency service organization.
- Authorize a tax credit for private employers who allow an employee-volunteer to leave work for training or to respond to an emergency call.

## State Street Bridge Renamed in Honor of Sen. Jim Rhoades

A measure I sponsored to designate the State Street Bridge over the Schuylkill River in Hamburg Borough and Tilden Township, Berks County, as the Senator Jim Rhoades Memorial Bridge was signed into law in November 2010.

Many of us in this chamber knew Jim Rhoades well and considered him a friend. Education was his passion, and ultimately, he became chairman of the Senate Education Committee. As Education chairman, Jim had a hand in crafting every major education initiative in recent history, including the Pennsylvania Safe Schools Act, the Pennsylvania Interscholastic Athletics Accountability Act and the Head Start Supplemental Assistance Program.

His unexpected and untimely death was a tremendous shock and a terrible loss, not only to his friends and family, but also to the Commonwealth as a whole. I am proud to have sponsored the bill to dedicate this bridge in Jim's old district in his honor

## The 95th Annual Pennsylvania Farm Show was a Success

The largest indoor agricultural exhibition in the United States, the 95th Annual Pennsylvania Farm Show was held from Jan. 8 to Jan. 15 at the Pennsylvania Farm Show Complex and Expo Center in Harrisburg. The eight-day show featured 6,000 animals, 10,000 competitive exhibits and 290 commercial exhibitors, and the nearly half-million visitors to the show experienced the opportunity to learn of the new developments in Pennsylvania's leading industry, agriculture. I always enjoy attending the Farm Show and meeting with residents of the 124th District who take part in the various events. I am particularly impressed by the dedication and expertise of the many young people who exhibit livestock each year.

## PACE and PACENET Provide Low-Cost Prescription Drug Assistance for Seniors

Senior citizens who rely on prescription drugs to stay healthy may qualify for financial assistance through the state's PACE and PACENET prescription drug assistance programs.

Eligibility restrictions for PACE require that applicants be residents of Pennsylvania for at least 90 consecutive days prior to application. Additionally, applicants must be age 65 or older and have a total income for the preceding calendar year of less than \$14,500 for a single person, or less than \$17,700 combined for a married couple.

Once enrolled in the PACE program, a benefit card will be mailed and enrollees will be required to pay a \$6 co-payment for each generic prescription medication. Brand name prescriptions require a \$9 co-payment. These co-payments are made to the pharmacy at the time of purchase.

PACENET members who enroll in a Medicare Part D plan will pay the Part D premium directly to the plan. Depending on the Part D plan one is enrolled in, monthly premiums will range between \$14.80 and \$28.45. In addition, Part D cardholders will pay no more than the PACENET co-payments of \$8 for each generic prescription medication and \$15 for each brand name to the pharmacy at the time of purchase.

PACENET members who do not enroll in a Part D plan will pay \$28.45 each month at the pharmacy toward the cost of their medications. If this is not paid on a monthly basis, it will accumulate. In addition, the individual will pay \$8 for each generic prescription medication and \$15 for each brand name.

## Knowles Closes Orwigsburg Office, Will Share Space with Tobash

I have said repeatedly that state spending is out of control. As we look for ways for state government to save taxpayer money, I believe lawmakers should lead by example. With that in mind, I examined my district office operations and I discovered there were several ways I could make more efficient use of taxpayer dollars.

Since I opened my district office in Orwigsburg, the office has not seen a great deal of constituent traffic. As a result, I could not justify the expense of keeping the office open. Therefore, I have decided to close the Orwigsburg district office and share office space with Rep. Mike Tobash (R-Schuylkill/Berks) at 988 E. Main St. in Schuylkill Haven to provide constituent services to residents in that area of the 124th district.

“People have said they want us to reduce expenses where we can,” said Tobash. “We do not want to duplicate resources in close proximity, so this decision makes sense. While the office is not in Representative Knowles’ district, it is very close, so people in that part of the district can get to it relatively easily.”

I want to thank Rep. Tobash for allowing us to use space in his Schuylkill Haven office. By sharing space with him, we are saving money while keeping up the level of service residents in that area of our district have come to expect.

Because Schuylkill Haven is outside my district, I will pay no rent on the office. A part-time member of my staff will work out of Tobash's office at least two days a week. The only additional expense will be a phone line dedicated to calls for my office.
